### EDUCATION, EXPERIENCE:

Michele de' Medici earned a Master of Acupuncture degree from TAI-Sophia Institute (formerly the Traditional Acupuncture Institute) in Columbia, Maryland on October 15, 1990. Michele completed a three-year Acupuncture Certification Program in Maryland, in May 1986. The program included training in the United Kingdom with the Master of this Five Element Acupuncture Tradition, Dr. JR Worsley. Michele completed an additional year of studies and clinical training in the San Francisco Bay Area before being awarded the Master's Degree. The entire Acupuncture and Oriental Medicine training program consisted of 3,416 educational program hours and 2,240 total didactic hours.

In 1989 Michele earned her California Acupuncture License, and the National Certification Commission for Acupuncture and Oriental Medicine (NCCAOM) certified her as a Diplomate of Oriental Medicine. This included certification in Clean Needle Technique.

Michele is registered as a Licensed Acupuncturist in the state of Colorado. She was Licensed as a Doctor of Oriental Medicine (DOM), in the state of New Mexico in 2010. Michele is a Registered Nurse, BSN from Seton Hall University, School of Nursing in South Orange, New Jersey. Provider has held licenses in Arizona, California and Maryland. These licenses have been allowed to lapse in past years. She has a current RN license in New Mexico. None of these licenses, certifications, or registrations has ever been suspended or revoked.

Provider uses only prepackaged, sterilized, disposable stainless-steel needles in her practice.
